

**GENERAL RELEASE OF LIABILITY AND MEDIA CONSENT
FOR COLORADO SPRINGS AIRPORT TOUR**

I, the undersigned, release and discharge the City of Colorado Springs ("City"), a home rule city and Colorado municipal corporation, acting by and through the Colorado Springs Municipal Airport, an enterprise of the City, and all of its officers, elected officials, successors, assigns, employees, attorneys, agents, servants and insurers, if any, of and from any and all liability for any and all claims, demands, damages, costs, liabilities, expenses, compensation, reimbursement, attorney's fees, rights and causes of action, arising or growing out of and by reason of, any and all known or unknown, foreseen and unforeseen injuries sustained and the consequences thereof, which may now or hereafter result from or which may or will result or will arise out of, directly or indirectly, my participation in a tour of the Colorado Springs Municipal Airport, including all of its land and facilities, or the filming, recording, or use of my appearance as described below.

I grant permission to the City to, in connection with my participation in a tour of the Colorado Springs Municipal Airport, film, record, and use in such a manner as it may deem desirable, my appearance, including, without limitation, my voice, image, or performance, in any video, film, movie, sound recording, photograph, or other form of data compilation whether created by electronic, digital, magnetic, analog, or mechanical means by the City or any of its officers, employees, agents, designees, or successors

I waive all rights to compensation, and acknowledge that I am to receive no compensation for such use of my appearance, and that I am to receive no compensation of any kind as a result of any use thereof. I grant the City the right to edit, reproduce, transmit, broadcast, exhibit, distribute, copyright, market, use, or reuse my appearance in whole or in part in any manner or media including, without limitation, use in print, e-mail, television, radio, the Internet, social media, podcast, stream, or any other form of media, in perpetuity throughout the world.

I assign to the City all of my rights to any such video, film, movie, sound recording, photograph, or other form of data compilation. The City shall have complete ownership of any such video, film, movie, sound recording, photograph, or other form of data compilation and the exclusive right to make use thereof as it deems appropriate.

I also grant permission to the City to use my name, likeness, and biographical material in connection with the use of my appearance as described above or in any other manner the City deems appropriate.

I warrant that no promise or agreement not expressed in this General Release of Liability and Media Consent has been made to me; that in executing this General Release of Liability and Media Consent, I am not relying on any statement or representation made by the parties released in this General Release of Liability and Media Consent, but am relying solely on my own judgment.

I acknowledge that I have read this General Release of Liability and Media Consent and understand the terms set forth in the General Release of Liability and Media Consent.
